

PRIVACY STATEMENT

Personal Data Rockfield Real Estate B.V. is the operator of the website www.Rockfield.nl. Your personal data will be used by Rockfield Real Estate B.V. for the purpose of providing you with the services offered on the website and enabling you to use our website in a manner that takes account of your preferences and interests.

This personal approach is possible because we may store certain data. Naturally, we respect and safeguard your privacy by complying with the European Privacy Directive (95/46/EC) and the Personal Data Protection Act.

For the sake of completeness, we note that Rockfield Real Estate B.V. is regarded as the 'controller' of personal data within the meaning of the Personal Data Protection Act. Where this privacy statement refers to Rockfield Real Estate B.V., it means: Rockfield Real Estate B.V. and its group companies (Rockfield Property Management BV). Below is set out which personal data are processed by Rockfield Real Estate B.V., the purposes for which these data are processed and how you can inspect and, if necessary, correct your personal data.

What personal data are processed?

Rockfield Real Estate B.V. in any case processes the data provided to it by you (e.g. the given telephone number, e-mail address, name, home address, reactions, interests and preferences). As a matter of principle, Rockfield Real Estate B.V. does not process special personal data, including data concerning race, religion, philosophy of life, political preference, health, criminal past or trade union membership.

However, Rockfield Real Estate B.V. reserves the option of processing these special personal data if you give your express consent or if these data have been expressly disclosed by you. Credit check Rockfield Real Estate B.V. draws your attention to the fact that it may carry out a credit check when requesting a lease, in order to assess a possible financial risk. This includes, for example, looking at (negative) payment experiences in recent years. In addition, Rockfield Real Estate B.V. consults the Opportunities C Complaints Register, which records undesirable tenant behaviour such as housing fraud, rental fraud, improper use of leased property and nuisance. Undesirable tenant behaviour is also reported by Rockfield Real Estate B.V. in the Opportunities C Complaints Register.

Quantified data

In addition, Rockfield Real Estate B.V. keeps track of which subjects or applications interest visitors by, among other things, checking which subjects or websites are visited most frequently. These data are processed on an aggregated and anonymous basis for use by Rockfield Real Estate B.V. or made available to third parties. They can best be compared to viewing and listening figures on television and radio. In doing so, no personal data are processed and the anonymity of each individual visitor is guaranteed. On the basis of this data, Rockfield Real Estate B.V. is best able to ascertain which subjects of the website are found most interesting by visitors, enabling Rockfield Real Estate B.V. to better tailor the website to visitors' interests. In order to collect the above aggregated information, a small file called a cookie is sent to your computer. A cookie is mainly intended to give you the

opportunity to download our website faster in the future. A cookie can also ensure, for example, that you do not have to enter your departure postal code each time you use the route planner. Furthermore, a cookie does nothing more than record the way in which you use our website, from which site you visit www.Rockfield.nl, how long you visit our site, when you leave www.Rockfield.nl and to which site you subsequently go (or log out). The partners Rockfield Real Estate B.V. works with have their own privacy terms. Rockfield Real Estate B.V. is not responsible and cannot be held liable for any acts or omissions of these partners in contravention of privacy laws and regulations.

Cookies

Rockfield Real Estate B.V. uses cookies for the following purposes: Measuring, on an aggregated level of user behaviour within the website of www.rockfield.nl. The purpose of this measurement is: to improve the online service from Rockfield Real Estate B.V. to its (online) customers based on aggregated measurement data (and therefore not individual). To retrieve such measurement data, indirect (3rd party) cookies are used which you yourself, if desired, can activate and/or deactivate in your browser and/or internet settings; providing online services to individuals based on authorisation. Direct cookies are used for this purpose. These can also be activated and/or deactivated in your browser and/or internet settings. If direct cookies are "off" in your browser, you will not be able to use all services offered by the website www.Rockfield.nlu as a visitor/customer. If you do not want us to use cookies, you must activate and/or deactivate this option yourself in your browser and/or internet settings. If you accept cookies, they will remain in your computer for five years, unless you delete the cookies (whether or not automatically through settings of your computer / internet settings to be managed by you). PLEASE NOTE: disabling cookies may limit your use of our website, www.Rockfield.nl, and services.

Purposes of data processing

Rockfield Real Estate B.V. processes the above-mentioned data in order to provide visitors who (wish to) use the services offered on the website with these services and to give them the opportunity to make active use of the website, taking into account visitors' personal preferences and interests. In addition, Rockfield Real Estate B.V. processes the data for general relationship management as well as internal acquisition/marketing purposes. The data are processed in accordance with the law, in a proper and careful manner and are not further processed in a way which is incompatible with the purposes for which Rockfield Real Estate B.V. obtained them. Under no circumstances will Rockfield Real Estate B.V. provide your personal data to third parties (being persons or companies outside Rockfield Real Estate B.V.) for their marketing activities without your explicit consent. Rockfield Real Estate B.V. takes the utmost care to implement appropriate technical and organisational measures to secure personal data against loss or against any form of unlawful processing. Information and rights regarding data You may inform Rockfield Real Estate B.V. that you do not wish to receive direct marketing from Rockfield Real Estate B.V. If you believe that your personal data are incomplete, incorrect or irrelevant to the purposes for which they are processed by Rockfield Real Estate B.V., you may correct, supplement or delete your personal data.
